1. I have contacted CPS and they did not want to take a report "because there is no student name" and it is an "Out of home" issue. I was told by Adrianan Andrade (CPS) to report it to SD Unified PD.
2. I contacted Sargent Espenoza and since there is no accuser, we can't adequately move forward with an investigation.
3. I have attached the other students statements and they don't seem to be pointing to any confirmation of the events reported.

4. At this time, we don't have any witnesses, student identified or substantiating evidence.

Carolanne – Not sure what next steps we have here with regards to this investigation? Mr. Teachworth told me there was an accusation many years ago but that that investigation was also dismissed.

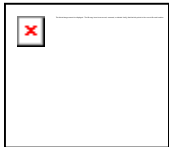

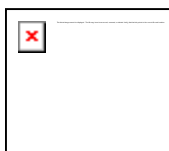
