



**CONTINUATION OF COMPLAINT:**

**Mario Alberto ESTRADA-Lorenzo**

**PROBABLE CAUSE STATEMENT**

On August 2, 2018, Border Patrol Agent M. Escobedo was conducting assigned duties in the Imperial Beach Border Patrol Station's area of responsibility. At approximately 8:30 PM, Agent Escobedo was notified by Remote Video Surveillance System Operator, National Guardsman Specialist Fernando Garcia, of two subjects heading north through the secondary fence, west of an area known by Border Patrol agents as the "Whiskey 8 Vehicle Gate." Agent Escobedo responded to the area and observed a semicircular cut in the secondary fence. Specialist Garcia guided Agent Escobedo to the two subjects, including one later identified as the defendant, Mario Alberto ESTRADA-Lorenzo, attempting to conceal themselves by laying down on the downhill slope. Agent Escobedo exited his vehicle and encountered the two subjects. This area is located approximately two miles west of the San Ysidro, California, Port of Entry, and approximately twenty yards north of the United States/Mexico International Boundary. Agent Escobedo approached the subjects, identified himself as a Border Patrol Agent, and conducted an immigration inspection. Both subjects, including ESTRADA, stated they are citizens of Mexico without any immigration documents that would allow them to enter or remain in the United States legally. At approximately 8:44 PM, Agent Escobedo placed both subjects, including ESTRADA, under arrest. During administrative processing, ESTRADA stated that he entered the United States on August 2, 2018.
